Sub: Request for reclassification from Promoter group category to Public category of Prakash Industries Limited

Ref.: Reclassification under Regulation 31A of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("SEBI LODR") from Promoter group category to Public category of Prakash Industries Limited.

#### A. Background and Current Status

While filing disclosure with stock exchange by Prakash Industries Limited ("the Company") has classified us under the category of "Promoter Group" of the Company as per Definition of Promoter Group in Securities and Exchange Board of India (Issue of Capital and Disclosure Requirements), Regulation, 2018 but we along with PAC are not holding any Equity Share in the Company.

### B. Request for Re-classification

We have been mentioned as a "Promoter Group" of your Company and request you to re-classify its status from "Promoter Group" to "Public Category", since we are not connected directly or indirectly whatsoever, with any activity of the Company nor have any direct or indirect control, over the affairs or the decision making process of your Company.

#### A. Undertaking:

- In this regard, we along with persons related to us together hereby confirm and undertake as follows:
  - "Persons related" as mentioned herein shall have the meaning as defined in Regulation 31A(1)(b) of the SEBI (Listing and Obligations and Disclosure Requirements) Regulations. 2015(as amended)
  - a) do not hold more than 10% (ten percent) of the total voting rights in the Company;
  - b) do not exercise control over the affairs of the Company, directly or indirectly,
  - do not have any special rights with respect to the Company through formal or informal arrangements including through any shareholder agreements;
  - d) are not represented on the board of directors of the Company (including through nominee director);
  - e) are not acting as a key managerial person in the Company;
  - f) are not 'wilful defaulters' as per the Reserve Bank of India Guidelines; and
  - g) are not fugitive economic offenders.

- We shall continue to comply with the conditions mentioned at sub-clauses (i), (ii) and (iii) of clause (b) of Regulation 31A(3) of the SEBI LODR Regulations at all times from the date of reclassification, failing which. We shall be reclassified as person belonging to the 'promoter group' of the Company;
- 4. We shall comply with the conditions mentioned at sub-clauses (iv) and (v) of clause (b) of Regulation 31 A (3) of the SEBI LODR Regulations for a period of not less than three years from the date of reclassification, failing which, We shall be reclassified as person belonging to the 'promoter group' of the Company.

We, AIRCON SYSTEMS (INDIA) PRIVATE LIMITED request the Board of Directors of the Company to consider and approve our request of reclassification from 'Promoter and Promoter group' to 'Public' category and make requisite application to the Stock Exchanges in accordance with Regulation 31A of the SEBI LODR Regulations. We shall extend all necessary cooperation including providing all necessary information/documents as may be required with respect to the reclassification, as and when required, to facilitate the process.
